

The Otoe County Board of Commissioners convened in regular session on Tuesday, November 25, 2014 at 8:30 a.m. in the County Courtroom 108 of the Otoe County Courthouse. Minutes of the previous meeting were not read as each Board Member was furnished with copy of the same. Members present were Steven Lade, Carol Crook, Rick Freshman and Charles R Hauptman. The following motions were passed by majority vote: To grant Sheriff Gress permission to advertise for the purchase of two new patrol vehicles. To sign and enter into an interlocal agreement with the governing boards of PSAPs located within 15 counties in southeastern Nebraska regarding the development of a funding method by which the political subdivisions will share in the costs of creating a Southeast Regional 911 System. To approve payment of tuition costs for eight AEMT students (at the rate of \$2,125 each) with no reimbursement requirements. To terminate a contract with Maly Marketing as recommended the Otoe County Visitors Committee.
