

The Otoe County Board of Commissioners convened at 8:30 a.m. on Tuesday, January 30, 2024, in the District Courtroom. Minutes of the previous meeting were not read as each Board Member was furnished with copies of the same. Members present were Jerad Sornson, Rick Freshman, James Parsons, Dan Crownover, and Chuck Cole. The following motions were passed by majority vote: to adopt Resolution #1-30-24-3 authorizing the pre-approval of a purchase from the SE PET Region Fund in the amount of \$5,321.20; to provide a letter of support for the Great Plains Communication CPF application for Syracuse Rural with the understanding that there are no county funds provided to the project; to adopt Resolution #1-30-24-4 to approve the setting of a date, time, and location of a public hearing regarding the road vacation of a section of county road located in the West ½ of the NE ¼ of Section 3, Township 8N, Range 9E; to award the proposal to Murphy Tractor contingent on the possibility of a trade option.
