

The Otoe County Board of Commissioners convened at 8:30 a.m. on Tuesday, April 9, 2024, in the District Courtroom (208) of the Otoe County Courthouse in Nebraska City. Minutes of the previous meeting were not read as each Board Member was furnished with copies of the same. Members present were Commissioners Jerad Sornson, Rick Freshman, James Parsons, Dan Crownover, and Chuck Cole. The following motions were passed by majority vote: to adopt Resolution #4-9-24-12, authorizing the collection of fees by the Otoe County Clerk's office for specified services; to approve the Class I liquor license application submitted by The Acreage; to approve the subdivision plat of Peterson Heights Subdivision, a 3.20+- acre tract located in the South ½ of the NE ¼ of Section 26, T 9N, R 13E as proposed by Randall S. Peterson and Brenda S. Peterson; to approve the conditional use permit to the Nebraska City Utilities to allow the application of bio-solids on various farm sites in Otoe County; to approve the conditional use permit to the City of Omaha (Missouri River Treatment Plant and Papillion Creek Treatment Plant) to allow the application of wastewater sludge on various farm sites in Otoe County; to approve the KENO application submitted for a contribution to purchase bronze grave markers for veterans; to approve the placement of an air monitoring station; to enter a three-month moratorium on applications for conditional use permits for commercial/utility grade solar energy systems until the commissioners have an opportunity to receive a report from the solar energy system zoning review committee regarding the current zoning regulations.
